4. The Art Walk assumes no responsibility whatsoever for any property displayed on the Avenue. The Exhibitor acknowledges he/she is responsible if property is left unattended and his/her own risk.
5. The Art Walk reserves the right to cancel this contract if the exhibitor fails to abide by the rules and regulations set forward by The Art Walk in the 2011 handout without reimbursement.
6. The Exhibitor agrees to leave the premises clean and tidy, and to repair at his/her own expense any damage caused by the exhibition.
